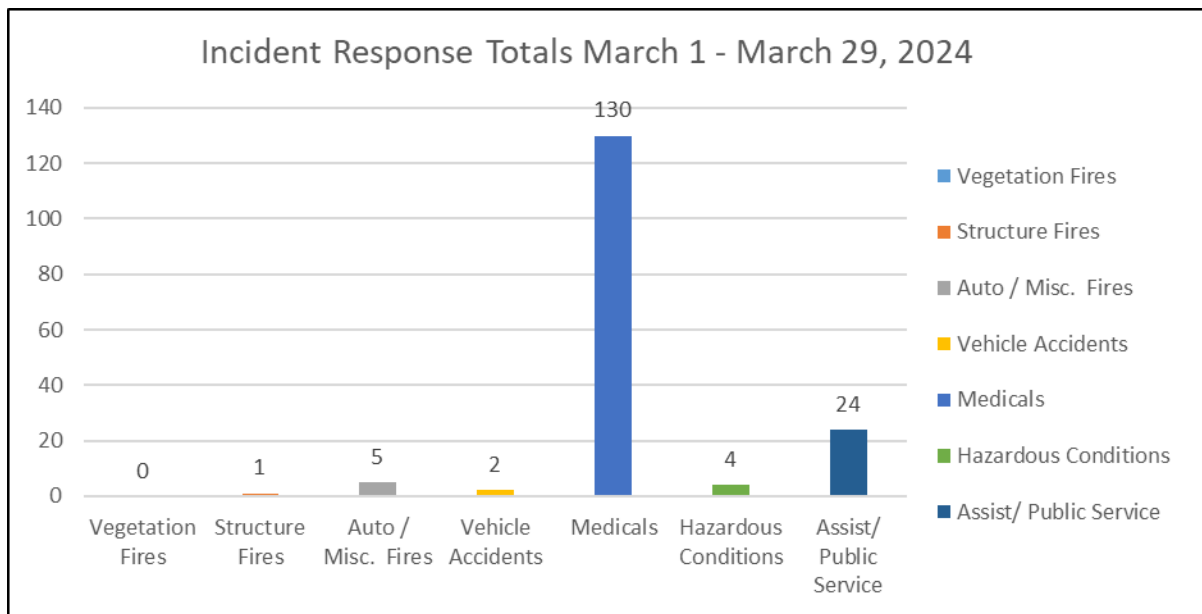

Cameron Park Fire Department Operations and Administration Report

- On March 4th, 2024, B2715, E89, E388, E88, E86, E26, T85, and M86 responded to an apartment fire on Greenwood Lane within station 89's first due area. Upon arrival, E89 reported a two-story apartment complex with fire visible from the roof. Shortly after, B2715 arrived and assumed command of the incident. Fire personnel on scene executed an aggressive fire attack, conducted evacuations, and successfully contained the fire to the attic and chimney chase of the involved apartment. No injuries were reported, and the cause of the fire was unintentional.
- During the last week in March, the CAL FIRE Amador - El Dorado Unit secured a commercial building located at 3421 Palmer Drive in Cameron Park. This facility will serve as the Ponderosa Fire Center, accommodating seven firefighter hand crews. These crews will be available for local, regional, and statewide responses to wildland fires and all-risk emergencies. Daily staffing at the center will include up to 60 personnel, comprising fire captains, engineers, and firefighters.
- On March 23, 2024, B2711, E88 and E89 responded to a passenger vehicle fire on Hacienda rd, within Station 89's first due area. Upon their arrival, firefighters encountered a well involved passenger vehicle. Action was taken to extinguish the flames, and effective containment measures ensured that the fire remained confined to the vehicle of origin.
