RE: Summer 2016 Softball League Registration

Thank you for your interest in the Cameron Park Summer Adult Softball Leagues. The summer season will start the beginning of June 2016. Start dates will be determined based on field conditions and availability. We have outlined what steps you need to take to register your team below.

Summer Registration Deadline – Friday, June 3, 2016 at 4:00pm

Registrations must be hand delivered or mailed to Cameron Park CSD at 2502 Country Club Dr., Cameron Park, CA 95682. The office is open Monday through Friday 8:00am-5:00pm. Be sure your name and signature is on your registration when it is delivered. Registration priority is first come first serve.

Cameron Park will use ASA sanctioned rules, and games are officiated by ASA certified umpires. We offer men's and coed leagues. All leagues are separated by skill and experience. Teams are guaranteed a 7-game schedule. At the end of the season the top four teams will play in a single-elimination playoff at the end of the season to determine the league champion. Playoff format may vary depending on the number of teams in the division.

Registration Requirements:

1. **League fee is \$450.00** and must be paid in the form of cash, personal check, sponsor's check, or credit card (Visa, Master Card, or American Express). Only one personal check will be accepted. Please make checks payable to: **CPCSD**. Fee increases to \$470.00 May 27th.
2. **A completed team roster** with player name, addresses, phone number, email, and signature is required at time of registration. Rosters must include a minimum of 10 players, with a maximum of 16 players. Rosters must be legible to be accepted, they can be hand printed or typed. No exceptions!
3. **A team sports league request form** must be completed and signed by the team manager. This acknowledges that you have read and understand the Sports Code of Conduct and the softball league rules.
4. **FULL PAYMENT, SIGNED LEAGUE ENTRY REQUEST FORM, and COMPLETED ROSTER must be received at the time of registration. NO EXCEPTIONS!!**

- All players must be at least 18 years old to play.
- A player may not play on more than 1 (one) team within the same division. It is the responsibility of the manager to ensure their team does not violate this rule.
