SUMMARY OF ORDINANCE NO. 2016.10.19
ADOPTION OF THE 2016 CALIFORNIA FIRE CODE**

By action taken by the Board of Directors of the Cameron Park Community Services District on October 19, 2016, the following Summary of Ordinance No. 2016.10.19, California Fire Code Ordinance, is hereby authorized to be published in a newspaper of general circulation throughout the jurisdiction of Cameron Park Community Services District in order to notify citizens of the adoption of Ordinance No. 2016.10.19. That public hearing occurred on October 19, 2016, at 6:30 p.m. at 2502 Country Club Drive, Cameron Park, California 95682.

The following Summary of Ordinance No. 2016.10.19 is adopted by the Board of Directors of Cameron Park Community Services District pursuant to the provisions of Government Code Section 25124(b)(1).

This Summary shall be published within fifteen (15) days after the meeting of the Board of Directors at which time Ordinance No. 2016.10.19 was adopted.

The following constitutes the official Summary of Proposed Ordinance No. 2016.10.19 California Fire Code Ordinance of the Cameron Park Community Services District.

Ordinance No. 2016.10.19 will adopt the 2016 California Fire Code and enable all District personnel to follow one set of rules and regulations with regard to the health and safety of the public and the District's response thereto. It will regulate and govern the safeguarding of life and property from fire and explosion hazards arising from the storage, handling and use of hazardous substances, materials and devices, and from conditions hazardous to life or property in the occupancy of buildings and premises within the Cameron Park Community Services District, Fire Department; providing for the issuance of permits and collection of fees therefore; repealing Ordinance No. 2010.11.17 of the Cameron Park Community Services District Fire Department and all other ordinances and parts of the ordinances in conflict therewith.

THE BOARD OF DIRECTORS HEREBY DIRECTS District staff to publish and post this Summary of Ordinance No. 2016.10.19 as provided in Government Code Section 25124.


