AGENDA ITEM #2: RECREATION REPORT

RECOMMENDED ACTION: RECEIVE AND FILE

May was focused on recruiting and hiring staff for summer programs, prepping for summer camps, classes, and staff training. We have 48 staff, both new and returning, for this year's Camp CP and aquatics programs. We are excited for the season ahead!

We also had our first annual Cardboard boat races as part of our summer kick-off event! The event included Recreation swim, Kidz Kreamery came out to offer treats for sale, and we had cardboard boat races.







Summer Spectacular is about a month away. One of our bands had to drop from the event, but our sound technician is helping us to secure another. We have met with our CAL FIRE partners to ensure that all will be ready for the event, and will meet again prior to the event. Tailored Trees is sponsoring our golf carts again this year, which is a huge help to the event. Wristbands are officially on sale. We raised the price due to the rising costs of services and supplies to \$15 per wristband. We also shortened the event slightly with gates opening at 4:30pm and music beginning at 5:00pm. This will help reduce staff hours and overall event costs. We are still seeking volunteers to help us make the event go well. We are looking forward to a great event!

We are sad to not have the slide during this summer but are hopeful to bring in a different amenity for the community.

Community Outreach Survey is still up for participation. As of this report, we have 311 participants. It has been emailed out several times in the E-newsletter, posted on social media, is on the front page of our website, and flyers are posted in every room and front

office of the community center. We will be doing one final push for responses, and then will close it to analyze results.

AGENDA ITEM #3: PARKS & FACILITIES DEPARTMENT REPORT

RECOMMENDED ACTION: RECEIVE AND FILE

General Information

- The Department will be presenting a new staffing model to the Budget & Administration Committee on June 6, 2023. The staffing model will create promotional opportunities for staff along with the ability to retain staff and provide succession planning for the department.
- Staff continue to work with Growlersberg and contractors to keep district
 properties fire safe. Staff meet with Cal Fire to walk properties that need
 attention. The department will continue scheduling Growlersberg and
 contractors to help maintain district properties with the resources we have.

Cameron Park Lake

- The department is seeking quotes to have the east side of the maintenance shop fence rebuilt. The fence is falling into the inlet of the lake. Once the fence is rebuilt the department will need to rebuild the bank of the inlet. The New Years Eve storm washed the bank away.
- Staff rented a Bob Cat with a brush cutter to knock down the weeds at the disc
 gold course. El Dorado Weed Control will also be spraying out the spillway to
 eliminate the vegetation. This is required by the State Department of Water
 Resources.

Parks and LLAD'S

- Christa McAuliffe Soccer Field reopened to the Community on May 15th. Christa McAuliffe was closed for spring maintenance which included aeration, seeding, fertilizing and irrigation repair.
- The Parking lot at Rasmussen Park has been repaired. Sierra Nevada Asphalt replaced several sections of asphalt that were crumbling away. This was likely caused by the amount of rain and runoff we received this winter. There is little to no road base underneath the existing asphalt.
- The department approved Ponderosa Little League to upgrade the existing batting cage/bullpen at Dave West Park. Ponderosa Little League installed permanent fencing along with a concrete pad.
- Heartwood Tree Company removed a tree that fell across the pathway at Northview Park. Heartwood also chipped up several large piles of branches and green waste collected over the winter.
- A vehicle crashed into the concrete sound wall along Meder Road. The sound wall is part of Northview Park LLAD. The district obtained the police report and has reached out to the driver who was insured.
- The department rented a tractor to repair the trail at Rasmussen Park. The trail completely washed out this winter when the BLM creek overflowed onto the park. Staff couldn't repair the trail until the ground fully dried out. Staff will be grading the trail with the material on site. When the trail washed out it sent all the decomposed granite down Monukka Drive and into the Culverts along Cameron Park Drive. The department does not want to spend that kind of money until the BLM creek is repaired. The department is also worried about clogging culverts down Monukka Drive when the BLM creek overflows again.

Community Center

- Lawton Construction is waiting for the subcontractor to finish repairing and painting the gutters. The dry rot has all been repaired and the main entrance is back open. We are hoping to close out this project in the next few weeks.
- The repair of the water slide has stopped for the moment. Facility staff ran into several spots where the rust had eaten its way through the steel. The steel framing

has been compromised. There is also a large crack in the top of the water slide tube. Facility staff are working with the manufacturer to see if the parts are available to repair the damage. Staff will be providing updates as we gather more information.

• The department held interviews to hire a new Maintenance Worker II for the Community Center. The district made a job offer to Bailey Briggs which he accepted. Bailey's will be starting with the district on Monday June 5th.

CAL FIRE / Growlersberg

- May 9th knocked down the weeds on the Cameron Park Lake Dam.
- May 30th spent the day at Knollwood Park cleaning vegetation. The department learned the District is responsible for more acreage at Knollwood Park.

AGENDA ITEM #5: CONDITION OF THE COMMUNITY CENTER WATER SLIDE

RECOMMENDED ACTION: DISCUSSION/RECOMMENDATION


Introduction

The Community Center water slide is non-operational due to a significant amount of rust and a large crack on the slide tube. Staff begun addressing the rust in the early spring of 2023. This was a recommendation from the Department of Industrial Relations (DIR) in 2022. The District's Browning Reserve calls for a new water slide structure in 2023-24.

Background

Every year DIR inspects the District's water slide prior to the public using it. In 2022, DIR recommended the District address the rust that was visible on the water's slides frame. Facility staff began addressing the rust in March of 2023 by grinding it off the frame and repainting the steel. Facility staff were making progress until they came to a section of rust that had gone through the metal in more than one location. The holes caused by the rust have compromised the structure. Upon further inspection staff found a large crack in the plastic tube where it connected to the top of the structure. In the fall of 2022, kids hopped the fence at night and used the pool facility. Staff noticed the kids forced their way through the locked gate and used the water slide. This could have caused the crack in the slide tube.

Matt Bustabade, the Parks and Facilities Supervisor, is working with Natural Structures, the slide manufacturer, to see how much it would cost to repair the slide. There is a 6–8-week lead time on the delivery of parts. Repairing the slide will be a large undertaking. The slide will be closed for the 2023 swim season.





Fiscal Impact

Historically, the recreation swim program has not been a profitable program on its own. This is believed to be due to the amount of staffing required to open the pool, the low number of

attendees, and the rising operational costs. With the closure of the slide, we have already begun to receive requests for refunds of Annual Passes after our opening weekend without the slide. We anticipate that attendance will drop further without a replacement amenity.

Additionally, the design of this pool is not conducive to families looking to enjoy the pool. The shallow end is a very small space, and limited movement due to ropes required to meet guidelines for the current slide. The remaining pool space is very deep and only usable by those able to swim well or adults looking for space for lap swimming. The lack of shade is another drawback and a reason many of our community members choose to go to other pools per feedback received.

Recommendation

Staff recommends that the District purchase an inflatable amenity suitable for ages six and older. We believe this will be a draw for many in the community and is consistent with current industry trends and neighboring agencies who have seen success with a similar amenity. We believe this amenity would be an asset regardless of the availability of the slide. The staffing would be no greater than what is currently required.

Staff also recommend having further discussions regarding possibilities of replacing the slide and other potential projects for the pool area that we believe add value as a summer attraction as we look at the changing population of Cameron Park and as we look to the future of this facility and the community.

AGENDA ITEM #6: PARKS & RECREATION MASTER PLAN UPDATE

RECOMMENDED ACTION: Discussion and Recommendation

Introduction

At the May 1, 2023, Parks & Recreation committee meeting, the General Manager was asked to research consultants that develop Parks Master Plans, specifically costs associated with the development of a comprehensive Parks Master Plan or Parks & Recreation Master Plan.

Discussion

The General Manager contacted companies that provide master planning services. A total of 3 consulting companies were contacted. When briefing the interim GM Jill Ritzman about this report she indicated that there was an existing 10-year Parks & Recreation Master Plan Update (dated 2014) for the District (attachment 5a). It is an update to an earlier plan adopted in 2000. The document was not posted to the District website (that has been corrected) which, along with a lack of institutional knowledge, was the reason staff were not aware of the document. The 100-page report will expire in 2024, which makes considering another Master Plan update an option that could be cost effective. The 2014 Parks & Recreation Master Plan Update was used as the foundation for the Park Improvement Plan (attachment 5b).

Fiscal Impact

The cost estimate is between \$100,000 and \$200,000 for a new comprehensive 10-year Parks Master Plan. Given that short notice of the existing Parks & Recreation Master Plan Update, staff have not had sufficient time to request quotes for updating the Master Plan.

Recommendation

Staff recommends that the Parks & Recreation Committee request that staff seek cost estimates from the consultant that developed the current Master Plan Update along

with cost estimates from some other landscape architect firms to provide a price range, and bring that information back to a future PRC meeting. This will also allow time for the Committee and staff to review the existing document prior to a future discussion and the development of next steps.
