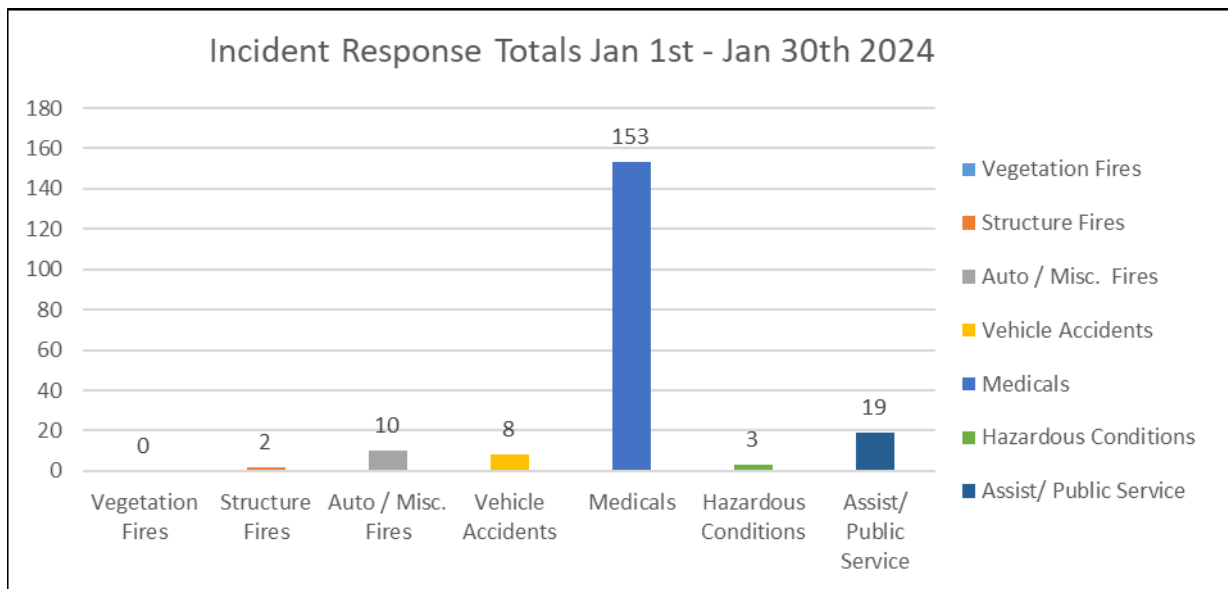

Cameron Park Fire Department Operations and Administration Report

- On January 20th, B2705, E89, E88, EDH E86, E85, and ECF E26 responded to a residential structure fire on Kimberly Road in Station 89's first due. Upon arrival, B2705 reported a small fire in the exterior wall of the structure. The fire was quickly extinguished, resulting in minimal damage and no injuries.
- E388 and B2705 were staffed by the Office of Emergency Services from January 21 to 22 and again from January 31 to February 1 in anticipation of winter storms. Their primary mission was to offer surge staffing and rescue services to the region.
- On January 29th, B2705, E88, E89, EDH E86, RES E283, and ECF E28 responded to a residential structure fire on Alhambra Dr in Station 88's first due. Upon arrival, E88 reported a small kitchen fire, leading to smoke filling the house. The homeowner had already extinguished the fire before the crews arrived. Personnel remained on the scene to check for extension and ventilated the structure to remove smoke.
