

HAVE A MERRY CHRISTMAS SCAVENGER HUNT!

Think you can spot Santa around town? Our “**Have a Merry Christmas Scavenger Hunt**” is on! We’ll be moving our **3-foot-tall Santa Sign** to different locations throughout the community, and it’s up to YOU to find him!

HOW TO PLAY

1. FIND SANTA!

Keep your eyes peeled around the community for our **3-foot-tall "Have a Merry Christmas" Santa Sign**.

2. TAKE A PHOTO!

When you find Santa, take a photo with the sign. Your photo must clearly show **you (or your participating group) with the Santa Sign AND enough of the surrounding location to identify where you found it**.

3. SCAN THE QR CODE!

Scan the QR code provided on the official scavenger hunt materials to access the entry form.

4. SUBMIT YOUR ENTRY!

Complete the online entry form and upload your photo. Be sure to provide all requested information so we can contact you if you are selected as a winner.

5. KEEP HUNTING!

Santa may move! You can either search the community or look for clues on our Social Media platforms! Check back often and keep your eyes open for his next appearance around the community.

PRIZES & WINNERS

At the conclusion of the scavenger hunt, **three winners will be selected by random drawing (the more entries, the more chances of winning!)**:

1st Place: CP CSD Individual Annual Pass

2nd Place: 1 Year Lake Pass

3rd Place: \$50 CP CSD Gift Certificate (can be used towards Annual Pass, CSD Programs & Events)

Winners will be contacted using the information provided on their entry form.

SCAVENGER HUNT DATES

Starts: September 2, 2025

Ends: December 16, 2026

All entries must be submitted by **December 18, 2026**, to be eligible for the prize drawing.

PHOTO REQUIREMENTS

To qualify for the drawing, your submitted photo must:

- Clearly show the participant(s) with the official **"Have a Merry Christmas" Santa Sign**.
- Clearly show the surrounding area or recognizable location where the sign was found.
- Be submitted through the official online entry form using the QR code.
- Be submitted by the contest deadline.

IMPORTANT RULES

- The Santa Sign will be moved to various public locations throughout the community.
- Participants must **not move, alter, damage, or interfere with the Santa Sign**.
- Please do not enter restricted, private property, or otherwise unauthorized areas to locate the sign.
- Participants are responsible for following all posted rules and safety guidelines at each location.
- One photo submission per person, per sign location, unless otherwise specified by the event organizers.
- Photos must be taken during the official scavenger hunt period.
- **Each entry must include a new photo showing the participant(s) with the Santa Sign and the location where it was found.**
- Entries that are incomplete, illegible, or do not meet the photo requirements may be disqualified.
- Prizes are non-transferable and have no cash value unless otherwise stated.
- Employees of the Cameron Park Community Services District and their immediate family members are not eligible to participate.
- By submitting a photo, participants grant the Cameron Park Community Services District permission to use the submitted photo for promotional purposes, including social media, websites, newsletters, and other District communications.
