WEED ABATEMENT SUMMARY FOR JUNE 2019 CSD BOARD MEETING

- Researched returned mail addresses and resent to the updated address.
- Received approximately 45 phone calls from local residents regarding Weed Abatement issues and improved lot inspections.
- Completed approximately 22% of improved lot inspections.
- Continue vacant lot inspections to determine properties to lien.
- Prepared list of properties for possible liens.
- Acquire bids from contractors for liens. Met with contractors on site to answer questions regarding our ordinance requirements.
- Determine based on costs which lots to lien.
- Hired 3 contractors to begin work on clearing properties.
- Sent out courtesy letters to 9 property owners notifying them that we will begin the process of clearing their property.
- Waiting for bids on 8 more properties.
